# Case Settles At Mediation

Based upon the insurance company's refusal to reasonably evaluate

#### What is "Mediation"?



Mediation is a term used to describe a formal settlement conference, usually court ordered, in which the parties to a lawsuit retain a neutral third person, referred to as a Mediator, to assist the parties in settling their claim.

At the mediation conference, which can last from a few hours to an entire day, the attorneys present a brief summary of what they expect the evidence to be at trial. The mediator does not decide who caused an accident or the value of the case, but the mediator does use his or her training in negotiations to help the parties reach a settlement.

One purpose of a mediation conference is to reach an agreeable settlement of a personal injury claim, early on in the process, thereby avoiding the unnecessary delays, expenses and uncertainties of trial.


# How did Hancock & Hancock get started?

Michael – "In 1996 I left a successful insurance defense law firm where I had practiced law for several years because I had wanted to represent individuals in personal injury cases. So in 1996 I formed my own law firm dedicated to representing individuals and families in personal injury and wrongful death claims. By 2001, my practice had grown so much that I needed the help of another attorney. My wife, Claire Hancock, who was at the time working for another prominent personal injury firm in Tampa, left her practice and we formed Hancock & Hancock, P.A."

# How do you organize your work together, especially as husband and wife?

**Michael** - One of the things that works so well between the two of us is that we each enjoy different aspects

of practicing law. I would much rather be in the courtroom, at an adversarial hearing, taking depositions of defendants and expert witnesses or presenting our clients' cases in mediations and trials. That's where I am happiest.



Claire – From the beginning, we had a clear plan how to best utilize each of our own areas of expertise, and by following through with that plan, revising it as necessary and staying flexible, we are able to best serve our clients.

# How do you balance your professional and personal lives?

Michael: It is not always easy. Representing personal injury clients often involves working on cases, and talking with clients well past 5:00 pm. The law is a profession where it is easy to find yourself thinking and strategizing about your clients and their cases 24-hours-a-day, seven days a week. There are many times when I am at home

with Claire and our two wonderful daughters that I might think, "I need to talk to Claire about an expert, or about a deposition, or an upcoming mediation or trial..."

But you have to quickly decide whether you can wait until you return to the office the next morning to discuss the matter or whether it does need to be discussed at home. Over time I have learned to focus on family time so we can really be "mom and dad" while we are away from the office. However that does involve a constant and ongoing prioritization of work and family matters.

Claire: For those times when we are at home and it is necessary to put work before the family, for instance, when we are preparing for mediation or trial, our fully functional home office is networked into our office server, giving us access to all of our case information and the legal research necessary, and that gives us the ability to be at home as a family.
